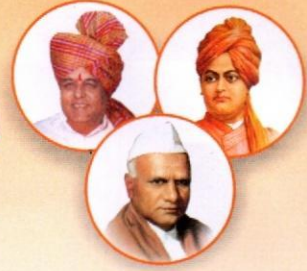

V. SIGNATURES

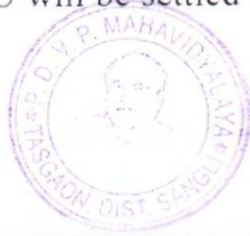
The MOU is written and signed in two copies having equal force, each party receiving two copies for the record.

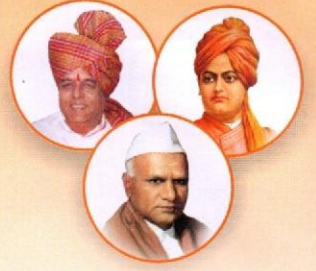


