#### Terms and Conditions

1. DCK has to undertake website maintenance work under the guidance of the Principal Padmabhushan Dr. Vasantrodada Patil Mahavidyalaya, Tasgaon.
2. No advance will be paid Vendor has to submit the bill first half after six month and remaining after six months.
3. PDVPT keeps its right to reject all/party/cancel the process at any time without giving any reason for same.
4. PDVPT keeps right to terminate the agreement at any time with one notice to vendor.
5. If the DCK fails to provide the required services within stipulated time, Principal, Padmabhushan Dr. Vasantrodada Patil Mahavidyalaya, Tasgaon shall have right to assign full/party work to next technically qualified vendor at the risk and cost of the first vendor.
6. DCK has to sign an agreement as per the rules and regulations of Padmabhushan Dr. Vasantrodada Patil Mahavidyalaya, Tasgaon.
7. DCK has to study existing website code and then undertake the website maintenance work.
8. Our website software code is in html/.Net and SQL server for database.






9. The existing hosted information is very important and it should be handled very carefully, confidentially it is very sensitive data. It is the responsibility of the Vendor to take maximum care in handling the data and its recovery.
10. It is the responsibility of the DCK to take regular backup of website DCK should have all technical knowledge of server settings, software installation etc.
11. In case of any loss of information hosted PDVPMT, College website or any loss / damage to existing database PDVPMT, College may impose penalty on the DCK.
12. It is the responsibility of the DCK to keep the website updated. Any upgradation received from various sections / programs regarding existing website has to be hosted immediately.
13. DCK has to keep daily log of work done.
14. It is the responsibility of the DCK for keeping secrecy of various passwords allotted to them for updating of PDVPMT, College Website. They should not share said confidential information with anybody else.
15. PDVPMT, College Website is using SQL server for data base handling. Website maintenance should be carried out on college campus under the supervision of Principal, Padmabhushan Dr. Vasantrodada Patil Mahavidyalaya, Tasgaon.
16. Website maintenance services has to be given from 01<sup>st</sup> August, 2023 to 30<sup>th</sup> September, 2024.
17. Vendor has to submit latest / modified full source code of PDVPMT college website to Principal, on 31st July 2024.



